Introduction

The IACP/Booz Allen Hamilton Leadership in the Prevention of Terrorism Award recognizes agencies that have demonstrated overall success in averting, stopping, or countering terrorist activity. It is meant to highlight successful counterterrorism investigations and educate the law enforcement field on instances reflective of collaboration and communication best practices during terrorism investigations.

Criteria for selection includes, but is not limited to:

- Demonstrated success in averting a terrorist attack.
- Arrest, indictment, or other legal actions of/against individuals, organizations, or countries found to be financially or otherwise supporting a known terrorist organization.
- Development of a new or innovative approach or technique to aid deterrence.
- Leadership in building cooperation and communication with municipal, county, state, and regional partners to deter terrorist activity.
- Leadership in establishing community-based awareness campaigns.
- Demonstrated cooperation by submitting department/agency with other law enforcement agencies or civilian organizations in countering terrorism.

All law enforcement agencies that have successfully averted, stopped, and/or taken legal action against individuals, organizations, or countries found to be supporting a known terrorist organization or engaging in terrorist activities.




