**Chief Jonathan Lewin** oversees the Bureau of Technical Services and serves as the Chief Information Officer for the Chicago Police Department, where he leads advanced initiatives to support public safety. Most recently, he oversaw development and implementation of the Department's innovative Strategic Decision Support Centers (SDSCs), a collaboration with the University of Chicago Crime Lab and the Los Angeles Police Department to bring real-time situational awareness technology and processes to Chicago's busiest police districts.

He serves on the Board of Officers for the International Association of Chiefs of Police (IACP) Law Enforcement Information Management Section (LEIM), the State of Illinois Law Enforcement Information Task Force, the Illinois e-Discovery Task Force, and the Department of Homeland Security (DHS) Video Quality in Public Safety (VQiPS) working group. Lewin was appointed as the Major Cities Chiefs of Police representative on SAFECOM and FirstNet's Public Safety Advisory Council (PSAC) in 2017 and the Department of Homeland Security Science and Technology (S&T) Directorate First Responder Resource Group in 2018. He earned a Bachelor of Science in Administration of Justice degree at Southern Illinois University, a Master's degree in Public Policy at Northwestern University, and a Master's degree in Security Studies at the U.S. Naval Postgraduate School.

**Sean Malinowski, Ph.D.**

**Deputy Chief Sean Malinowski** is the Chief of Staff to Los Angeles Police Chief Charlie Beck. As the Chief of Staff, he manages the Department's staff officers, provides strategic advice to the chief and oversees high priority projects. Malinowski also manages the LAPD's Predictive Policing program and is the principal investigator for the federally-funded "Smart Policing Initiative."

For nearly two years now, Deputy Chief Malinowski has been engaged by the Department of Justice to work with the Chicago Police Department, the University of Chicago Crime Lab, and the Baltimore Police Department to assess the department's crimefighting infrastructures and to implement new data-driven violence reduction strategies.

As a Captain, Malinowski served as Commanding Officer in two of LAPD's 21 Divisions and also served as the C.O. for the Department's Crime Center where he oversaw the LAPD's Compstat process.

Malinowski joined the LAPD in 1994 and has worked patrol assignments in South Los Angeles, in the San Fernando Valley and in the west side beach community of Venice. As a sergeant, he worked Patrol, Internal Affairs and Training Division and as the Executive Officer for former LAPD Police Chief Bill Bratton.

Dr. Malinowski earned his Ph.D. in Public Administration from the University of Illinois. He is a Fulbright Scholar and a Senior Fellow at the Homeland Security Institute at Long Island University. In 2015, Dr. Malinowski was inducted into the George Mason University, Evidence-Based Policing Hall of Fame.



**Special Agent Matthew Swenson** currently serves as a National Program Manager at the Department of Homeland Security Cyber Crimes Center in the Cyber Crimes Unit. He is in charge of the Cyber Intrusion Response Program (CIRP) and is an instructor for the Network Intrusion First Responder Program (NIFR). Mr. Swenson has more than 15 years of federal law enforcement experience focusing on digital forensics, cyber-crime, and incident response. He has also taught computer forensics and cyber-crime related courses to investigators worldwide, to include Europe, Asia, Africa, Central and South America, and at the Federal Law Enforcement Training Center in the United States.
